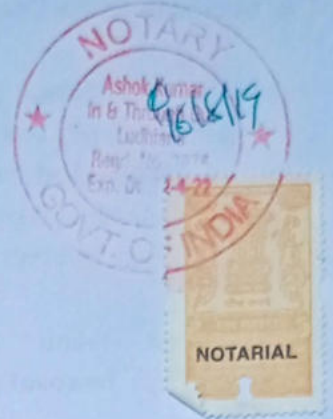

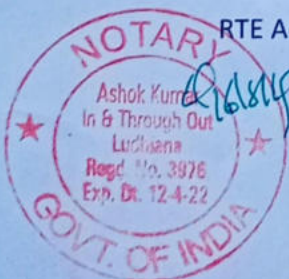

1. In future if at any time of complaint/inspection it is found that you have made any false statement or you have hidden any fact and if you do not follow the instructions of Punjab Government given from time to time and if you do not follow the conditions mentioned in the affidavit your NOC can be taken back.
2. You are bound to teach Punjabi till 10<sup>th</sup> standard and C.B.S.E, New Delhi will also make arrangements to conduct the Punabi exam in such schools and it is also being said that failure to this, your NOC certificate will be taken back.
3. School management is bound to follow rules and regulations laid down by the RTE Act 2009 by Education Department, Punjab Government.

4. After taking affiliation from C.B.S.E New Delhi, the management is liable to pay the salary and all the allowances as given to Govt. employees through A/c payee cheques. NOC will be cancelled if not done. In case of extension and upgradation the requisite Reserve fund of teaching and non-teaching staff will be deposited to the DEO.
5. You and your Management are bound to co-operate and provide information to DEO or any other senior officer of Education Department and you will provide the requisite information when demanded. If not done NOC will be cancelled.
6. The officials of Punjab Government will inspect and ensure compliance regarding safety of children, public health sanitation and other certified conditions for issuance of NOC at regular intervals.
7. The guidelines issued by Punjab Government under letter no. 2/93/2009/3C3/1360154 dated 26.11.2018 will be exactly followed.

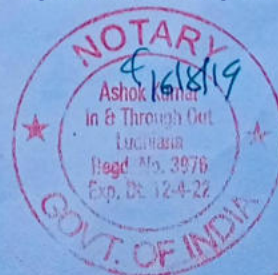

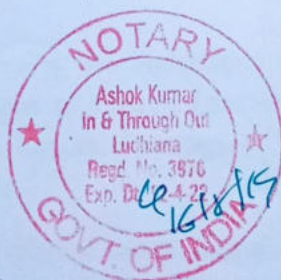
